CERTIFICATE OF DATA DESTRUCTION

This document details the procedures we perform to ensure all sensitive data is completely removed from any storage mediums that are donated to Human-I-T. To quarantee full data protection, we only use procedures that are in full compliance with HIPAA, The HITECH Act, and other data security standards.



TRANSPORTATION & STORAGE All storage mediums donated to us get transported and locked inside of a secure facility while they await processing.



HARD DRIVE DATA SANITIZATION Using a NIST 800-88 method, we overwrite existing data with random data throughout the entire storage medium to destroy any leftover data. Then, we rescan the hard drive to verify that all data has been wiped.



PHYSICAL CRUSHING If software-based methods are unable to verify absolute data destruction, we'll physically crush the storage medium and then responsibly recycle it via an R2 certified* organization.



ALL DATA IS ERASED INCLUDING

- · NTFS, FAT/exFAT, HFS+ volumes from areas containing deleted and unused data
- File slack space (unused bytes in the last cluster occupied by file)
- Free clusters (unused by file data sectors)
- Deleted MFT records on NTFS and Directory system records on FAT/exFAT

The R2v3 Standard establishes responsible reuse and recycling ("R2") practices for the management and processing of used electronics globally. By certifying to this Standard through an accredited third-party Certification Body, an R2 Facility can help IT asset managers, sellers of used electronics, and prospective purchasers of IT Asset Disposition, refurbishment, remarketing, and recycling services (among others) make informed decisions and have increased confidence that used electronic equipment is managed in an environmentally responsible manner, protective of the health and safety of workers and the public, and that all data on all devices is secure and effectively destroyed.
